FEMA Manufactured Housing Units (MHUs) are designed to be exceptionally safe and secure, but all forms of housing are at risk for damage in severe weather.

- Never take shelter in an MHU during high winds, a tornado, a hurricane or a flood.
- If severe weather is predicted, stay alert to weather warnings and always follow the guidance of local officials including evacuation orders.
- If your MHU is damaged due to severe weather, contact the maintenance number you were provided when you were licensed in your unit.

You can find Disaster Recovery Centers (DRCs) by going online or using the FEMA smartphone app.

- Survivors who need in-person help can visit any open DRC. Find locations online at fema.gov/DRC
- You can also locate a list of DRCs on the FEMA app, available for Apple and Android devices. To download, go to fema.gov/mobile-app, look under "Disaster Resources" and then find the "Talk to FEMA in Person" section and tap on it to get the list.

Texas Recovery Hurricane Harvey: Partnerships and Progress

All totals as of April 9, 2018

- 41 individual assistance counties designated
- 53 public assistance counties designated
- 41,500 square miles of land mass impacted (larger than Connecticut, Massachusetts, New Hampshire, Rhode Island and Vermont combined)
- 372,234 approved registrations (+172 since April 2)
- **306** participating National Flood Insurance Program (NFIP) communities in declared areas

- \$1.1 billion in the 30-day estimate for the hazard mitigation grant program
- 4,291 households in FEMA-funded hotels (-722 since April 2)
- 14,445 survivors in temporary housing and innovative repair programs (+483 since April 2)
- 1,261 requests for public assistance (+2 since April 2)
- 13 million cubic yards of storm debris picked up (+1 million since April 2)
- 142 obligated projects for \$633 million (+18 projects and +\$3 million since April 2)
- \$13.55 billion in survivors' pockets + (\$5 million since April 2)
- \$1.60 billion in housing and other disaster-related expenses (+10 million since April 2)
- \$3.31 billion in U.S. Small Business Administration (SBA) loans approved (+20 million since April 2)
- **\$8.64 billion** in National Flood Insurance Program (NFIP) advance payments and claims paid (estimate) (+20 million since April 2)
- \$23 million in disaster assistance unemployment
- **91,000** flood insurance claims

Direct Housing

The housing mission is federally funded, state-administered and locally managed. The State of Texas and local officials are leading the way in finding new solutions to help Texans impacted by Hurricane Harvey. As of April 8:

- 2,669 housed through the direct housing program
