MINUTES OF CITY OF WHARTON REGULAR CITY COUNCIL MEETING April 11, 2011

Mayor Domingo Montalvo, Jr. declared a Regular Meeting duly open for the transaction of business at 7:00 P.M. Mayor Domingo Montalvo, Jr. led the opening devotion and the pledge of allegiance.

The second item on the agenda was Roll Call and Excuses Absences. Councilmember Bryce D. Kocian moved to excuse Councilmember Don Muller. Councilmember Terry David Lynch seconded the motion.

The third item on the agenda was Public Comments. Mr. I.O. Coleman, Jr. addressed the City Council with his support of an ordinance approving the traffic control plan for the James Simmons, Jr. 2nd Annual Juneteenth Festival. Mr. Coleman added that he also supported a resolution approving the offer by Just Do It Now, Inc. to acquire tax resale property described as Lots 3 & 4, Block 9, Harrison Addition to the City of Wharton and a resolution approving the offer by Just Do It Now, Inc. to acquire tax resale property described as an undivided 80 % interest in and to Lots 5 & 6, Block 9, Harrison Additional to the City of Wharton, Texas, Wharton County, Texas. No action was taken.

The fourth item on the agenda was the Wharton Moment. No comments were given. No action was taken.

The fifth item on the agenda item was to review and consider the reading of the minutes from the regular meeting held March 14, 2011 and March 28, 2011. After some discussion, Councilmember Jeffery Gubbels moved to approve the minutes from the regular meetings held March 14, 2011 and March 28, 2011. Councilmember Bryce D. Kocian seconded the motion. All voted in favor.

The sixth item on the agenda was a public hearing regarding the City of Wharton Transportation and Overpass Projects.

Mayor Domingo Montalvo, Jr. opened the public hearing regarding the City of Wharton Transportation and Overpass Projects at 7:34 p.m.

Mr. Don Middlebrook addressed the City Council and stated that the Industrial Foundation was encouraging the City to move forward with the project to extend FM 1301 to Highway 59. Mr. Middlebrook added the City of Wharton needed a presence on Highway 59, which would do a lot for the face of Wharton.

Mr. Lloyd Shoppa addressed the City Council and stated that he believed it was a positive action for the City Council to hear citizen input on the project. Mr. Shoppa recommended that the City Council's first choice be to take FM 1301 to Highway 59 or bend Boling Highway to prevent buying Subway and the mobile home park. Mr. Shoppa added that another concern was that some landowners had not been contacted about the purchase of their land.

Ms. Jeanene Merka addressed the City Council and stated that she supported taking FM 1301 to Highway 59. Ms. Merka informed the City Council that she owned a small piece of property that would probably be part of the acquisition of land for the project and she would be willing to give that property to the City if the project was taken all the way to Highway 59.

Wharton County Commissioner Chris King addressed the City Council and stated that he had been aware, for a few years, of the FM 102 Bypass project. Commissioner King applauded the efforts of the City Council for conducting the project that he believe would benefit the City of Wharton. Commissioner King added that he believed the FM 102 bypass would not be good for the City of Wharton at this time and recommended the project be put on hold.

Mr. Wayne Adam addressed the City Council and stated that he was a former business owner and he agreed with the comments to take FM 1301 to Highway 59. Mr. Adam added that taking FM 1301 to FM 102 would be a mistake.

Ms. Billie H. Jones addressed the City Council and stated that the City does not have a place to welcome people to the City. Ms. Jones stated extending FM 1301 to Highway 59 would give the

City a new "Front Door." Ms. Jones further stated downtown businesses were losing out and she urged the City Council to move forward with the project.

Dr. David Samuelson addressed the City Council and stated that he favored going from FM 1301 to FM 102. Dr. Samuelson further stated that adding the four corners to Highway 59 would mean constructing an additional overpass, which would cost more money. Dr. Samuelson stated that the City could not afford the project to be extended to Highway 59. Dr. Samuelson further stated that the big issue was safety. Dr. Samuelson added if there were a train wreak, emergency services would be cut off from the west side of town. Dr. Samuelson stated the City Council should consider extending to FM 102 first and then later look at extending to Highway 59. Mr. Jim Cockrell addressed the City Council and stated that the City Council needed to think about Hurricane Season and Wharton being an evacuation City. Mr. Cockrell added the fact that FM 102 flooded and proceeding with the extending FM 1301 to FM 102 would cause traffic issues.

Mr. David Mata addressed the City Council and stated that the City Council needed to consider the citizens before spending taxpayer's money. Mr. Mata stated that the City's infrastructure was falling apart.

Mayor Montalvo stated that he was forming a Transportation Committee. Mayor Montalvo stated that Mr. Lloyd Shoppa, Mr. Charles Davis, Mr. Stewart Morris, Mr. Fred Ziedman, and Mr. Jeffery Blair would serve on the committee.

Mayor Domingo Montalvo, Jr. closed the public hearing at 8:36 p.m.

The seventh item on the agenda was to review and consider the Planning Commission recommendation for City Council consideration to approve the request by Sarim, Inc. (Denny's), represented by Mr. James Shaw, Brite Lite Signs Agent, for a variance to the City of Wharton Code of Ordinances, Chapter 66 Signs and Advertising, Table I Allowable Heights for Freestanding Signs to construct a freestanding sign at a height of 79'3". Assistant to City Manager Jackie Jansky stated the Planning Commission met on Monday, April 4, 2011 and discussed the request by Sarim, Inc. (Denny's), represented by Mr. James Shaw, Brite Lite Signs Agent, for a variance to the City of Wharton Code of Ordinances, Chapter 66 Signs and Advertising, Table I Allowable Heights for Freestanding Signs to construct a freestanding sign at a height of 79'3". Mrs. Jansky advised the City Council that the Planning Commission voted to recommend the City Council consider approving the variance request. Mrs. Jansky presented a copy of the memorandum dated April 4, 2011 from Co-Chairman Mike Wootton providing the recommendation and a copy of the Planning Commission Communications that included a copy of the Application for Variance submitted by Mr. Shaw requesting the variance. Mrs. Jansky also presented a copy of the Code of Ordinances, Chapter 66 Signs and Advertising – Allowable Heights for Freestanding signs. She stated that the code allowed freestanding signs to be 50' feet in height; therefore, the request was for a 29'3" variance to construct the sign at a height of 79'3". After some discussion, Councilmember Bryce D. Kocian moved to approve the request by Sarim, Inc. (Denny's) for a variance to the City of Wharton Code of Ordinances, Chapter 66 Signs and Advertising, Table I Allowable Heights for Freestanding Signs to construct a freestanding sign at a height of 79'3". Councilmember Terry David Lynch seconded the motion. All voted in favor.

The eighth item on the agenda was to review and consider an ordinance approving the traffic control plan for the James Simmons, Jr. 2nd Annual Juneteenth Festival, authorizing the Police Department to redirect traffic and authorizing the Mayor of the City of Wharton to execute the

Texas Department of Transportation Agreement for the Temporary Closure of State Right of Way. City Manager Andres Garza, Jr., advised the City Council that during the regular March 14, 2011 Wharton City Council meeting, the Wharton City Council tabled the request by Mr. Paul Kearney, Juneteenth Celebration Committee Member, for City Council consideration to approve the closure of Burleson Street between Fulton and Polk Streets and Houston and Fulton Streets at the intersection with Elm Street between the hours of 6:00 p.m. – 10:00 p.m. for the James Simmons, Jr. 2nd Annual Juneteenth Festival pending the development of the proposed traffic plan recommended by the Texas Department of Transportation (TxDOT.) Police Chief Tim Guin advised the City Council that on March 30, 2011, the City Staff met with Mr. Richard Zahn of TxDOT and Mr. Greg Baines, representing the Juneteenth Festival Committee and discussed the proposed traffic plan required by TxDOT in order to close State Highway 60 (south bound toward Bay City) through the downtown area for the festival. Chief Guin presented a copy of the proposed traffic plan, which met TxDOT standards and a draft Temporary Closure of State Right of Way agreement required by the State. He said that the proposed traffic control plan would be similar to that as the one used for the Wharton Holiday Parade except that State Highway 60 north bound to Richmond Road would remain open to traffic at all times during the event.

City Manger Andres Garza, Jr., advised the City Council that the Juneteenth Festival Committee requested the City of Wharton implement the traffic control plan, which would require the City to fund the cost to implement the plan. Mr. Garza presented a copy of the memorandum dated April 6, 2011 from Public Works Director Carter Miska that indicated the cost to purchase the required signage would be \$788.00. Mr. Miska stated that it would be more cost effective to purchase the signs than it would be to rent the signs each time they were needed. City Manager Garza presented a copy of the quote to purchase the signs. City Manager Garza also presented a copy of the memorandum dated April 7, 2011 from Police Chief Tim Guin that indicated that 6 officers would be required to implement the plan, which would require approximately 36 hours of overtime. Chief Guin stated that the cost of overtime would be dependent upon which officers worked the event. He said that if off-duty officers were hired by the Juneteeth Festival Committee the cost would be \$1,080.00. After some discussion, Councilmember Terry David Lynch moved to approve the traffic control plan for the James Simmons, Jr. 2nd Annual Juneteenth Festival, authorizing the Police Department to redirect traffic and authorizing the Mayor of the City of Wharton to execute the Texas Department of Transportation Agreement for the Temporary Closure of State Right of Way and in accordance with the City of Wharton Ordinance No. 2011-07, which read as follows:

CITY OF WHARTON ORDINANCE NO. 2011 - 07

AN ORDINANCE APPROVING THE TRAFFIC CONTROL PLAN FOR THE JAMES SIMMONS, JR. 2ND ANNUAL JUNETEENTH FESTIVAL, AUTHORIZING THE POLICE DEPARTMENT TO REDIRECT TRAFFIC AND AUTHORIZING THE MAYOR OF THE CITY OF WHARTON TO EXECUTE THE TEXAS DEPARTMENT OF TRANSPORTATION AGREEMENT FOR THE TEMPORARY CLOSURE OF STATE RIGHT OF WAY.

- **WHEREAS,** the Juneteenth Committee wishes to hold the James Simmons, Jr. 2nd Annual Juneteenth Festival in the downtown area of the City of Wharton and has requested approval to close portions of State Hwy. 60; and
- **WHEREAS,** said festival requires the City of Wharton to close State Highway 60, known as Burleson Street from its intersection of Polk Street to Fulton Street; and
- WHEREAS, the closure of State Highway 60 will be for a time of less than four (4) hours; and
- WHEREAS, the closure will require the detouring of all traffic traveling south on State Highway 60 according to the map (Attachment A) attached to this ordinance; and
- **WHEREAS,** if there are any other ordinances that would be violated because of the re-routing of all traffic their suspension is hereby authorized; and
- **WHEREAS,** the City Council wishes to authorize the Mayor of the City of Wharton to execute the Agreement for the Temporary Closure of State Right of Way as required by the Texas Department of Transportation.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS, that:

- **Section I.** The traffic control plan for the James Simmons, Jr. 2nd Annual Juneteenth Festival is hereby approved.
- **Section II.** The detour route resulting from the closure of State Highway 60 is hereby approved as detailed in the attached map (Attachment A) which is hereby made part of this ordinance.
- **Section III.** The closure of all streets as indicated in said map identified in Section II are hereby authorized.
- **Section IV.** The traffic detour plan as identified is Section III above is hereby approved.
- **Section V.** The Chief of Police and City Staff are hereby authorized to make the necessary expenditures needed to ensure the safety of the public.
- **Section VI.** That the Mayor of the City of Wharton is hereby authorized to execute the Agreement for the Temporary Closure of State Right of Way as required by the Texas Department of Transportation.
- **Section VII.** This ordinance shall become effective on the 19th day of June 2011 and remain in effect until such time that State Highway 60 is reopened to all traffic.

Councilmember Jeffery Gubbels seconded the motion. All voted in favor.

The ninth item on the agenda was to review and consider:

A. Resolution: A resolution of the Wharton City Council accepting the Fiscal Year 2010 Assistance to Firefighters Grant from the Federal Emergency Management Agency (FEMA) and the Department of Homeland Security (DHS) for funding in the amount of \$108,000.00 for the City of Wharton EMS Department and authorizing the Mayor of the City of Wharton to execute all documents related to said grant. City Manager Andres Garza, Jr. presented a draft copy of the a memorandum dated March 30, 2011 to him from EMS Director John Kowalik providing a copy of the award package submitted to the City of Wharton from the Federal Emergency Management Agency (FEMA) and the Department of Homeland Security (DHS) for the Fiscal Year 2010 Assistance to Firefighters (ATF) Grant award for funding in the amount of \$108,000.00 for the purchase of equipment for use by the City of Wharton EMS Department. EMS Director John Kowalik recommended to the City Council acceptance of the grant, which would authorize the City Staff to submit the required documents requested in the grant award package. After some discussion, Councilmember Jeffery Gubbels moved to approve Resolution No. 2011-19, which read as follows:

CITY OF WHARTON RESOLUTION NO. 2011 - 19

A RESOLUTION OF THE WHARTON CITY COUNCIL ACCEPTING THE FISCAL YEAR 2010 ASSISTANCE TO FIREFIGHTERS GRANT FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) AND THE DEPARTMENT OF HOMELAND SECURITY (DHS) FOR FUNDING IN THE AMOUNT OF \$108,000.00 FOR THE WHARTON EMS DEPARTMENT AND AUTHORIZING THE MAYOR OF THE CITY OF WHARTON TO EXECUTE ALL DOCUMENTS RELATED TO SAID GRANT.

WHEREAS, the City of Wharton received funding from the Federal Emergency Management Agency and the Department of Homeland Security under the fiscal year 2010 Assistance to Firefighters Grant Program in the amount of \$108,000.00; and

WHEREAS, the Wharton City Council wishes to accept the grant award from the Federal

Emergency Management Agency and the Department of Homeland Security; and

WHEREAS, the City Council wishes to authorize the Mayor to execute all documents related to the grant.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS, THAT:

- Section I. The Wharton City Council hereby accepts the grant award in the amount of \$108,000.00 from the Federal Emergency Management Agency and the Department of Homeland Security under the fiscal year 2010 Assistance to Firefighters Grant Program.
- **Section II.** The Mayor of the City of Wharton is hereby authorized to execute all documents related to the grant.
- **Section III.** This resolution shall become effective immediately upon its passage.

Councilmember Terry David Lynch seconded the motion. All voted in favor.

B. Resolution: A resolution of the Wharton City Council approving the purchase of equipment for the EMS Department and to place remaining grant funds towards the lease purchase agreement with Houston Community Bank for the EKG Monitors. City Manager Andres Garza, Jr., presented a copy of the memorandum dated April 7, 2011 from EMS Director John Kowalik providing his request to purchase upgrades to equipment used by the EMS Department. Mr. Kowalik stated that, last year, the City applied for the ATF Grant for the Life Pack 15 with all upgrades included. He said the total cost for the monitor with all the upgrades was \$176,446.81 and since the ATF grant funding had not become available, the City moved forward and purchased the monitors, ambulance and supervisor vehicle through a lease/purchase agreement with Houston Community Bank (HBC). He stated that since that time, the City received the ATF funding in the amount of \$108,000 and \$15,000 from the Department of State Health Services (DSHS) for the purchase of the monitors. Mr. Kowalik requested that the City Council consider authorizing the equipment to be upgraded in accordance with the grant guidelines in the amount of approximately \$53,446 and to use the remaining funds to pay toward the balance

owed to HBC for the EGK monitors. After some discussion, Councilmember Jeffery Gubbels moved to approve Resolution No. 2011-20, which read as follows:

CITY OF WHARTON RESOLUTION NO. 2011 - 20

A RESOLUTION OF THE WHARTON CITY COUNCIL APPROVING THE PURCHASE OF EQUIPMENT FOR THE EMS DEPARTMENT AND TO PLACE REMAINING GRANT FUNDS TOWARDS THE LEASE PURCHASE AGREEMENT WITH HOUSTON COMMUNITY BANK FOR THE EKG MONITORS.

WHEREAS, the City of Wharton received funding from the Federal Emergency Management Agency and the Department of Homeland Security under the fiscal year 2010 Assistance to Firefighters Grant Program in the amount of \$108,000.00; and

WHEREAS, the Wharton City Council utilize said grant funds to purchase equipment to be used by the EMS Department in accordance with the grant requirements; and

WHEREAS, On August 23, 2010, the Wharton City Council approved Resolution No. 2010-59 approving the purchase of four (4) EKG monitors through a lease/purchase agreement with Houston Community Bank; and

WHEREAS, the Wharton City Council wishes to place the remaining grant funds toward the balance owed on the EKG monitors previously purchased by the City of Wharton through the lease/purchase agreement with Houston Community Bank; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS, THAT:

Section I. The Wharton City Council hereby the purchase of equipment to be used by the EMS Department in accordance with the 2010 Assistance to Firefighters Grant Program guidelines..

Section II. The Wharton City Council hereby approves that the City of Wharton shall place the remaining grant funds toward the balance owed on the EKG monitors previously purchased by the City of Wharton through the lease/purchase agreement with Houston Community Bank

Section III. This resolution shall become effective immediately upon its passage.

Councilmember Terry David Lynch seconded the motion. All voted in favor.

The tenth item on the agenda was to review and consider the City Council approval of the Ambulance Provider Permit request by Texas Critical Care Ambulance Service. City Manager Andres Garza, Jr., presented a copy of the application submitted by Aprea Group, LLC dba Texas Critical Care Ambulance for a City of Wharton ambulance provider permit. He also presented a copy of the memorandum dated April 1, 2011 from EMS Director John Kowalik recommending the City Council consider approving their request for an ambulance provider permit. City Manager Garza stated that City Attorney Paul Webb also reviewed the application, and he provided a copy of the letter dated April 5, 2011 from Mr. Webb that indicated the company was in compliance and in good standing with the Texas Department of Health and recommended the approval of the permit request. After some discussion, Councilmember Jeffery Gubbels moved to approve the Ambulance Provider Permit requested by Texas Critical Care Ambulance Service. The motion died for a lack of a second. No action was taken.

The eleventh item on the agenda was a resolution of the Wharton City Council approving a SmartNet GNSS Reference Network Host Agreement between the City of Wharton and LEICA Geosystems, Inc. and authorizing the Mayor of the City of Wharton to execute the agreement. City Manager Andres Garza, Jr., advised the City Council that on February 23, 2011, he met with Mr. Tyler Collier of Leica-Geosystems, Inc. who requested the City of Wharton to consider the placement of a GNSS antenna on the Civic Center roof for use by the company for GIS mapping purposes. City Manager Garza also provided a copy of the proposed SmartNet GNSS Reference Network Host Agreement that had been reviewed by Attorney Clarence A. West, the City's Telecommunication Attorney and City Attorney Paul Webb. City Manager Garza also provided the City Council a copy of Mr. Webb's recommendation letter dated March 9, 2011, which indicated that he found the agreement to be in order. City Manager Garza further provided a copy of Facilities Maintenance Director Bob Baker's memorandum dated April 7, 2011 providing his recommendation that the placement of the proposed antenna to be on the north side of the EMS Department located at the Wharton Civic Center. City Manager Garza stated that as part of the agreement between the City and Leica Geosystems, Inc., Leica would provide the City of Wharton with a GPS unit at no cost to the City. He said the unit to be provided as per the contract was a Zeno 15, which was for mapping grade surveys only. Public Works Director Carter Miska stated that had he met with Mr. Collier who indicated that the company would upgrade the unit to be provided to the City to a Viva Uno 15, which was also, for mapping grade survey's; however, it could be upgraded for use on engineering grade surveys (centimeter accuracy), if needed. He said that the Zeno 15 could not be upgraded. Public Works Director Miska presented a copy of the memorandum dated April 6, 2011 from him regarding the unit to be provided to the City and a copy of the email dated April 6, 2011 from Mr. Collier stating the substitution of the units would be acceptable. City Manager Andres Garza, Jr. stated that the Finance Committee met on Monday, April 11, 2011 at 6:00 p.m. and was recommending the City Council consider approving the agreement with the proposed upgrade of the unit to be

provided to the City. After some discussion, Councilmember Terry David Lynch moved to approve the SmartNet GNSS Reference Network Host Agreement with the Zeno 15 upgraded to the Viva Uno 15 and the City of Wharton Resolution No. 2011-21, which reads as follows:

CITY OF WHARTON RESOLUTION NO. 2011 - 21

A RESOLUTION OF THE WHARTON CITY COUNCIL OF THE WHARTON CITY COUNCIL APPROVING A SMARTNET GNSS REFERENCE NETWORK HOST AGREEMENT BETWEEN THE CITY OF WHARTON AND LEICA GEOSYSTEMS, INC. AND AUTHORIZING THE MAYOR OF THE CITY OF WHARTON TO EXECUTE THE AGREEMENT.

WHEREAS, Leica GeoSystems, Inc. wishes to install a SmartNet GNSS Reference Network Host antennae on the north end of the Wharton EMS Facility; and

WHEREAS, the City of Wharton and Leica GeoSystems, Inc. wishes to enter into an agreement to authorize said antennae placement; and

WHEREAS, the City of Wharton and Leica GeoSystems, Inc. wishes to be bound by the conditions set forth in said agreement; and

WHEREAS, the Wharton City Council wishes to authorize the Mayor of the City of Wharton to execute the agreement.

City Manager Garza also presented resolutions that were prepared by Attorney Charles A. "Chip" Sutton, Partner of Linebarger, Goggan Blair & Sampson, LLP, the City's delinquent tax attorney firm. City Manager Garza stated that Mr. Sutton also prepared the bid analysis for the two (2) properties. Mr. Baines advised the City Council that the properties Just Do It Now, Inc. would like to acquire were next to their current property and they would like to maintain them to keep the area looking well kept. After some discussion, Councilmember Terry David Lynch moved to approve City of Wharton Resolution 2011-22, which reads as follows:

City Manager Andres Garza, Jr. presented the City Council with the results of the bid opening for the City of Wharton Ogden Sanitary Sewer Line Replacement Project held on Wednesday, April 6, 2011 at 2:00 p.m. City Manager Garza also presented the City Council with a copy of the bid tabulation. Mr. Garza informed the City Council that the City received two (2) bids ranging from \$66,490.00 from Supak Construction, Inc. and \$69,094.00 from AR TurnKey Construction, Inc. Mr. Bradley C. Loehr, P.E. reviewed the bids and recommended the City Council consider awarding the contract for the project to Supak Construction, Inc. in the amount of \$66,490.00. City Manager Garza stated that he concurred with his recommendation. After some discussion, Councilmember Bryce D. - 2. **Resolution:** A resolution of the Wharton City Council awarding the contract to Barbee Electric for the City of Wharton Emergency Generator Quick Connect Project Alabama Road Water Plant and authorizing the City Manager to execute the agreement.

City Manager Andres Garza, Jr. presented the City Council a copy of the memorandum dated April 7, 2011 from Building Official Ronnie Bollom regarding the Emergency Generator Quick Connect Project concerning the Alabama Road Water Plant and the Wharton Fire Department. City Manger Garza advised that Mr. Bollom stated in his memo that while making connections to the emergency generator components at the Alabama Road Water Plant (Item A above), the contractor Electrical Automation Controls (EAC), had discovered there were some deteriorated electrical conductors. Mr. Bollom advised that the insulation on the conductors had become brittle causing unsafe conditions that were beyond repair and required replacement. Mr. Bollom added that the removal of the existing conductors was not feasible due to their condition; therefore, it was recommended that new conduit and conductors be installed. Mr. Garza stated that since this work was not covered under the under the agreement with EAC, Mr. Bollom received quotes for the work. City Manager Garza presented a copy of the tabulation of the quotes received from Barbee Electric and EAC. Mr. Bollom recommended to the City Council that they consider awarding the work to Barbee Electric, in the amount of, \$9,393.68. After some discussion, Councilmember Terry David Lynch moved to award the contract to Barbee Electric for the City of Wharton Emergency Generator Quick Connect Project – Alabama Road Water Plant, in the amount of, \$9,393.68, and in accordance with the City of Wharton Resolution No. 2011-25, which reads as follows:

B. Wharton Fire Department:

- 1. Quotes.
- 2. **Resolution:** A resolution of the Wharton City Council awarding the contract to Barbee Electric for the City of Wharton Emergency Generator Quick Connect Project Wharton Fire Department and authorizing the City Manager of the City of Wharton to execute the agreement.

City Manager Andres Garza, Jr. informed the City Council that Mr. Bollom further stated in his memorandum that since the Wharton Fire Station Expansion project had begun and the new building had been repositioned on the lot from the original design, it had been suggested that both the existing and new buildings be connected to a single electrical service. City Manager Garza stated that currently the proposed location of the attachment for the emergency power transfer switch and quick connects were to be located at the exterior of the back wall of the existing building, which was approximately 100 feet from the point of electrical service and the new building. Mr. Bollom further stated that the new service would allow the City to incorporate a single emergency power generator transfer switch with quick connects, rather than two separate systems, for both buildings using one meter at the initial entry point of electrical service. Mr. Bollom stated that the City could eliminate the need for an additional generator or cable(s) laid across the driveway to connect emergency power to the new building. City Manager Garza stated that Mr. Bollom requested quotes for the construction of the single source service and was recommending that the revised project be awarded to Barbee Electric to install the new service with a 600 amp manual transfer switch with quick connects in the amount of \$22,975.00. Mr. Garza further added Mr. Bollom was also recommending that the contract with EAC be revised to remove the installation of a 400 amp manual transfer switch and quick connects from the Wharton Fire Department scope of work in the original contract. City Manager Garza stated that a change order to the contract was being prepared and would be presented to the City Council at a future meeting. After some discussion, Councilmember Terry David Lynch moved to award a contract to Barbee Electric for the City of Wharton Emergency Generator Quick Connect Project – Wharton Fire Department in the amount of \$22,975.00, and in accordance with the City of Wharton Resolution No. 2011-26, which reads as follows:
