MINUTES OF CITY OF WHARTON REGULAR CITY COUNCIL MEETING JUNE 13, 2011

Mayor Domingo Montalvo, Jr. declared a Regular Meeting duly open for the transaction of business at 7:00 P.M. Councilmember Al Bryant led the opening devotion and led the pledge of allegiance.

The second item on the agenda was Roll Call and Excuses Absences. Councilmember Don Mueller moved to excuse Councilmember Jeff Gubbels from being absent. Councilmember Terry David Lynch seconded the motion. All voted in favor.

The third item on the agenda was Public Comments. No action was taken.

The fourth item on the agenda was the Wharton Moment. Mayor Domingo Montalvo, Jr. presented proclamations to the Wharton High School 2010-2011 UIL Participants in Sports, Academic and Band. He stated that the participants attended the state competition and represented the City of Wharton well. City Manager Andres Garza, Jr. introduced and welcomed Ricky Sherfield from the Texas Department of Agriculture Internship Program.

The fifth item on the agenda item was to review and consider the reading of the minutes from the regular meeting held May 9, 2011 and May 23, 2011 as presented. After some discussion, Councilmember Terry David Lynch moved to approve the minutes from the regular meetings

The sixth item on the agenda was to review and consider a request by Ms. Frances Crump c/o Ms. Jo Hale for an over 50% variance request for the placement of a 6'-8" x 6'-8" sign to be located at 102 West Alabama Street; Wharton, Block 54, Lots 1, 2. City Manager Andres Garza, Jr. presented a copy of the memorandum dated June 2, 2011 from Building Official Ronnie Bollom providing the application for an Over 50% Variance request submitted by Ms. Frances Crump c/o Ms. Jo Hale for a side yard setback variance for the placement of a 6'-8" x 6'-8" sign to be located at 102 West Alabama Street; Wharton, Block 54, Lots 1, 2. Mr. Garza also presented a copy of the application and supporting documentation. After some discussion, Councilmember Al Bryant moved to approve the request by Ms. Frances Crump c/o Ms. Jo Hale for an over 50% variance request for the placement of a 6'-8" x 6'-8" sign to be located at 102 West Alabama Street; Wharton, Block 54, Lots 1, 2. Mr. Garza also presented a copy of the application and supporting documentation. After some discussion, Councilmember Al Bryant moved to approve the request by Ms. Frances Crump c/o Ms. Jo Hale for an over 50% variance request for the placement of a 6'-8" x 6'-8" sign to be located at 102 West Alabama Street; Wharton, Block 54, Lots 1, 2 contingent upon the sign being constructed to allow for visibility at the bottom of the sign. Councilmember Don Mueller seconded the motion. All voted in favor.

The seventh item on the agenda was to review and consider a resolution of the Wharton City Council rescinding Resolution No. 2011-34 and approving the Multi-Jurisdictional Hazard Mitigation Action Plan prepared by the Texas Colorado River Floodplain Coalition. City Manager Andres Garza, Jr. stated that on May 9, 2011, the Wharton City Council approved Resolution No. 2011-34 approving the Multi Jurisdictional Hazard Mitigation Action Plan. Mr. Garza added that since that time, the Texas Colorado River Floodplain Coalition had made recommended changes to the plans introductory section. City Manager Garza further stated that the Federal Emergency Management Agency (FEMA) had asked that all entities that approved the plan prior to the changes being made (May 23, 2011) readopt the resolution approving the plan. City Manager Garza presented a copy of the email from Ms. Melissa Lerma, TCRFC and H2OPartners requesting that the resolution and plan be readopted. City Manager Garza stated that the City Staff was requesting City Council consideration to approve the plans re-adoption. After some discussion, Councilmember Terry David Lynch moved to approve the resolution rescinding Resolution No. 2011-34 and approving the Multi-Jurisdictional Hazard Mitigation Action Plan prepared by the Texas Colorado River Floodplain Coalition. City of Wharton Resolution No. 2011- 41 read as follows:

CITY OF WHARTON RESOLUTION NO. 2011-41 A RESOLUTION OF THE WHARTON CITY COUNCIL RESCINDING RESOLUTION NO. 2011-34 AND APPROVING THE MULTI-JURISDICTIONAL HAZARD MITIGATION ACTION PLAN PREPARED BY THE TEXAS COLORADO RIVER FLOODPLAIN COALITION.

WHEREAS, on May 9, 2011, the Wharton City Council approved Resolution No. 2011-34 approving the Multi-Jurisdictional Hazard Mitigation Action Plan; and

WHEREAS, the Federal Emergency Management Agency has asked each participating entity to reapprove the plan since modifications were made to the introductory sections of the plan; and

WHEREAS, the City of Wharton wishes to rescind Resolution No. 2011-34 approving the original Multi-Jurisdictional Hazard Mitigation Action Plan; and

WHEREAS, the City of Wharton wishes to approve said plan that was revised after May 23, 2011; and

WHEREAS, natural hazards in the Lower Colorado Basin historically have caused significant disasters with losses of life and property and natural resources damage; and

WHEREAS, the City of Wharton is a participating member of the Texas Colorado River Floodplain Coalition (TCRFC); and

WHEREAS, the Federal Disaster Mitigation Act of 2000 and Federal Emergency Management Agency (FEMA) require communities to adopt a hazard mitigation action plan to be eligible for the full range of pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, FEMA requires that communities update hazard mitigation action plans every five years in order to be eligible for the full range of pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, the City of Wharton has assessed the community's potential risks and hazards and is committed to planning for a sustainable community and reducing the long-term consequences of natural and man-caused hazards; and

WHEREAS, the TCRFC's Hazard Mitigation Plan Update outlines a mitigation vision, goals and objectives; assesses risk from a range of hazards; and identifies risk reduction strategies and actions for hazards that threaten the community.

NOW THEREFORE BE IT RESOLVED THAT:

- Section I. The Wharton City Council hereby rescinds Resolution No. 2011-34.
- Section II. The TCRFC's Hazard Mitigation Plan Update amended after May 23, 2011 as approved in its entirety;
- Section III. The City of Wharton will pursue available funding opportunities for implementation of the proposals designated therein, and will, upon receipt of such funding or other necessary resources, seek to implement the actions contained in the mitigation strategies;
- Section IV. The City of Wharton vests with the Mayor/County Judge the responsibility, authority, and means to inform all parties of this action; assure that the Hazard Mitigation Plan Update will be reviewed at least annually; and that any needed adjustments will be presented to the City Council/Commissioner's Court for consideration; and
- Section V. The City of Wharton agrees to take such other action as may be reasonably necessary to carry out the objectives of the Plan Update and report on progress as required by FEMA and the Texas Division of Emergency Management (TDEM).
- Section VI. That this resolution shall become effective immediately upon its passage.

The eighth item on the agenda was to review and consider the First Reading: Ordinance: An ordinance authorizing the Mayor of the City of Wharton to execute on behalf of the City of Wharton, Texas, an Electric Power Distribution Franchise with Wharton County Electrical Cooperative, Inc., and its successors and assigns ,to use the Public Rights-of-Way of the City for the Distribution of Electric Power; Providing for Period of Grant; for Consideration; for Construction and Relocation of System Facilities; for assignment; and for Publication in accordance with the Authority Granted in this Ordinance. City Manager Andres Garza, Jr. stated that during the May 23, 2011 Wharton City Council meeting, the City Council was presented a draft copy of a proposed franchise agreement between the City of Wharton and the Wharton County Electrical Cooperative (WCEC) for electric power distribution. Mr. Garza further stated the City Charter required that franchise agreements (ordinances) must be read at three separate meetings of the City Council. Mr. Garza presented a copy of the proposed ordinance and franchise agreement and a copy of the City Charter Section 117 regarding franchises. After some discussion, Councilmember Don Mueller moved to approve the first reading of the ordinance authorizing the Mayor of the City of Wharton to execute on behalf of the City of Wharton, Texas, an Electric Power Distribution Franchise with Wharton County Electrical Cooperative, Inc., and its successors and assigns to use the Public Rights-of-Way of the City for the Distribution of Electric Power; Providing for Period of Grant for Consideration; for Construction and Relocation of System Facilities; for assignment; and for Publication in accordance with the Authority Granted in the Ordinance. The City of Wharton Ordinance No. 2011-10, read as follows:

CITY OF WHARTON ORDINANCE NO. 2011-10

AN ORDINANCE AUTHORIZING THE MAYOR OF THE TO EXECUTE ON BEHALF OF THE CITY OF WHARTON, TEXAS AN ELECTRIC POWER DISTRIBUTION FRANCHISE WITH WHARTON COUNTY ELECTRIC COOPERATIVE, INC., AND ITS SUCCESSORS AND ASSIGNS, TO USE THE PUBLIC RIGHTS-OF-WAY OF THE CITY FOR THE City of Wharton Regular City Council Meeting June 13, 2011 DISTRIBUTION OF ELECTRIC POWER; PROVIDING FOR PERIOD OF GRANT; FOR CONSIDERATION; FOR CONSTRUCTION AND RELOCATION OF SYSTEM FACILITIES; FOR ASSIGNMENT; AND FOR PUBLICATION IN ACCORDANCE WITH THE AUTHORITY GRANTED IN THIS ORDINANCE.

The following statements are true and correct and constitute the basis upon which the City Council of the City of Wharton, Texas (the "**City**") may pass, approve and adopt this Ordinance:

WHEREAS, Texas Utilities Code § 41.005 provides that "An electric cooperative shall be an electric utility for purposes of Section 182.025, Tax Code, and Section 33.008."

WHEREAS, Texas Utilities Code § 33. 008(a) provides that, "a municipality may impose on an electric utility, transmission and distribution utility ... or electric cooperative that provides distribution service within the municipality a reasonable charge as specified in Subsection (b) for the use of a municipal street, alley, or public way to deliver electricity to a retail customer."; and

WHEREAS, Wharton County Electric Cooperative, Inc. is an "electric cooperative" as that term is defined in the Texas Utilities Code and wishes to use the City of Wharton's streets, alleys, and public ways to deliver electricity to retail customers; and

WHEREAS, the City of Wharton wishes to grant Wharton County Electric Cooperative, Inc. ("**Company**") the right to use its streets, alleys, and public ways to distribute electricity to retail customers for a reasonable charge; and

WHEREAS, the City of Wharton finds that the charge provided in this Franchise Agreement is reasonable and comparable to fees charged to other providers;

WHEREAS, the City Council has reviewed the terms and conditions of the agreement covering the City's grant of the Franchise to Company ("Franchise"), as described with greater specificity below; and

WHEREAS, the City Council adopts this Franchise Authorizing Ordinance which authorizes the Mayor of the City to execute a Franchise with Company on behalf of the City strictly upon the terms as set forth herein; and

WHEREAS, City of Wharton finds that the publication of this Ordinance, as required by the City Charter Section 117(b), fully complies with that Charter requirement, with the Franchise being available to the public to review in the City Secretary's Office; and

WHEREAS, upon passage, approval and adoption of this Ordinance, and after publication and written acceptance by the Company, the Mayor may execute the Franchise on behalf of the City, which Franchise shall include the terms and conditions as described herein; and

WHEREAS, as set forth herein, the terms and conditions of the Franchise are provided for summary purposes only and are limited in their entirety by the actual terms and conditions of the Franchise to be entered into by and between the City and the Company; capitalized terms not otherwise defined herein shall have the same meaning as set forth in the Franchise.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS:

The City Council adopts this Franchise Authorizing Ordinance authorizing the Mayor to execute on behalf of the City a Franchise with Company, which Franchise shall include the

following terms and conditions:

The term of the Franchise shall be no longer than ten (10) years;

Company shall provide the City with written acceptance of the Franchise in accordance with its term;

Company shall pay to the City on a quarterly basis a franchise fee in the amount of four percent (4%) of Company's Gross Revenue for the privileges conferred to Company under the Franchise, or the maximum allowed by Section 33.008 of the Texas Utilities Code;

City shall be allowed to review books and records of the Company to verify franchise fee payments;

Company shall agree to abide by with all applicable City ordinances concerning the construction, use, excavation, maintenance, operation, and removal of the Company's electrical system facilities that are in, on or over the public rights-of-way in the City;

Company shall relocate its electrical distribution facilities at its cost for City construction projects;

Company shall indemnify the City;

The Franchise may not be assigned or transferred by Company without the prior written consent of the City, as provided for in the Franchise

The Franchise shall provide for forfeiture and termination for material breaches;

Venue for disputes shall be in Wharton County; and

Company shall distribute electrical power service in full conformity with its tariffs, but only in the areas of the City where the Company is authorized to provide electrical power service. Upon publication of this Ordinance as required by the City Charter Section 117(b), and written acceptance of the Franchise by Company, the City Council hereby authorized the Mayor to execute on behalf of the City and with Company a Franchise having the terms and conditions as described above.

This Ordinance shall be in full force and effect following its publication in accordance with the City Charter Section 117(b).

Read in full and passed and adopted on first reading at a regular meeting of the City Council of Wharton, Texas, on the <u>13th</u> day of <u>June</u> 2011, and approved by the Mayor.

The ninth item on the agenda was to review and consider City of Wharton Emergency Generators Quick Connects for Certain City Facilities Project - Electrical Automation Controls (EAC):

A. Change Order No. 2.

City Manager Andres Garza, Jr. presented a copy of the memorandum dated May 19, 2011 from Building Official Ronnie Bollom regarding the Change Order No. 2 that would reduce the scope of work on the project, for the Wharton Fire Department outlined in the contract. City Manager Garza stated that since the bid to install the Automatic Transfer Switch at the Wharton Fire Department was awarded to Barbee Electric, the installation of the 400 amp manual transfer switch and cam lock assembly needed to be removed from the EAC contract but the company had received the equipment, which could not be restocked. City Manager Garza further stated the City had received the equipment and the \$5,216.97 represents its cost and the removal of this portion of the work from the contract scope of work was a result of changing the electrical service entrance to a 600 Amp service in order to provide electrical power to the existing building and new building and being able to utilize only one emergency generator and components.

B. Pay Request No. 4.

City Manager Garza presented a copy of the memorandum dated June 6, 2011 from Building Official Ronnie Bollom providing the Pay Request No. 4, in the amount of, \$13,392.12 for the City of Wharton Emergency Generators Quick Connects for Certain City Facilities Project being conducted by Electrical Automation Controls. City Manager Garza stated Building Official Ronnie Bollom was recommending the City Council consider approving the request for payment. After some discussion, Councilmember Terry David Lynch moved to approve both items A. Change Order No. 2 and B. Pay Request No. 4 as presented above. Councilmember Russell Machann seconded the motion. All voted in favor.
