The second item on the agenda was Roll Call and Excuses Absences. Councilmember Terry David Lynch moved to excuse Councilmember Russell Machann. Councilmember Al Bryant seconded the motion. All voted in favor.

The third item on the agenda was Public Comments. No comments were given.

The fourth item on the agenda was the Wharton Moment. No comments were given.

The fifth item on the agenda was a proclamation declaring June 15, 2013 as Dr. Charles W. Edwards, Jr. Day in the City of Wharton, Texas. Councilmember Al Bryant moved to approve the minutes from the regular meeting held April 8, 2013 and the regular meeting held April 22, 2013. Councilmember Don Mueller seconded the motion. All voted in favor.

The seventh item on the agenda was to review and consider a resolution of the Wharton City Council approving a contract between the City of Wharton and U.S. Capital Advisors for financial advisory services and authorizing the Mayor of the City of Wharton to execute the agreement. After some discussion, Councilmember Terry David Lynch moved to approve City of Wharton Resolution No. 2013-27, which read as follows:

A RESOLUTION OF THE WHARTON CITY COUNCIL ADOPTING THE CITY OF WHARTON INVESTMENT POLICY.

WHEREAS, the Public Funds Investment Act, requires the City Council to review and

adopt, by resolution, the investment policies and strategies for the City of

Wharton on an annual basis; and

WHEREAS, the City of Wharton designates the City Manager and the Finance Director

as investment officers; and

WHEREAS, the City of Wharton approves the training courses sponsored or endorsed

by the Texas Municipal League, the Government Finance Officers Association of Texas, the Government Treasurers Organization of Texas, or the North Central Texas Council of Governments as adequate to meet

the investment training requirements; and

WHEREAS, the attached investment policy complies with the Public Funds Investment

Act and authorizes the investment of City funds in safe and prudent

investments.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS that:

Section I. The City of Wharton has complied with the requirements of the Public

Funds Investment Act and the Investment Policy attached hereto as "Exhibit A" is hereby adopted as the Investment Policy of the City of

Councilmember Don Mueller seconded the motion. All voted in favor.

The ninth item on the agenda was to review and consider a request by Schulz Insurance Agency, for an Over 50% Variance for a Zero setback from the rear property line for the placement of a 29' x 37' modular building to be located at Wm.Kincheloe, Block 66, Lot 8,9; 1327 N. Alabama Road, Wharton, Texas. City Manager Andres Garza, Jr. stated that Schulz Insurance Agency was requesting a Zero setback variance for placement of a 29' x 37' modular building. Building Official Ronnie Bollom stated that City of Wharton Ordinance Sec. 18-77 stated: "Minimum rear building line setback: Ten feet, except where abutting existing or proposed residential uses, in which event the rear building line setback shall be 20'." Mr. Bollom said this would result in a Zero rear building line setback from the existing property line and the rear property line was separated from the residential use lots by a 20' easement and the building would be placed behind an existing business located at 1327 N. Alabama Road. After some discussion, Councilmember Don Mueller moved to approve the request by Schulz Insurance Agency, for an Over 50% Variance for a Zero setback from the rear property line for the placement of a 29' x 37' modular building to be located at Wm. Kincheloe, Block 66, Lot 8,9; 1327 N. Alabama Road, Wharton, Texas. Councilmember Al Bryant seconded the motion. Councilmembers Al Bryant, Terry David Lynch, Jeff Gubbels, and Don Mueller voted in favor. Councilmember Karen Schulz abstained. The motion carried.

The tenth item on the agenda was to review and consider an Ambulance Provider Permit Application submitted by EMCORPS. City Manager Andres Garza, Jr. presented a copy of the Ambulance Provider Permit Application submitted by EMCORPS a copy of the letter from City Attorney Paul Webb providing his comments regarding the application. City Manager Garza further presented a memorandum from EMS Director John Kowalik providing his recommendation for approval of the application. Mr. Webb stated that EMCORPS should update their address with the Secretary of State as a condition of approval of the application. After some discussion, Councilmember Don Mueller moved to approve the Ambulance Provider Permit Application submitted by EMCORPS with the provision that their address be corrected

with the Secretary of State. Councilmember Terry David Lynch seconded the approval. All voted in favor.

The eleventh item on the agenda was to review and consider a request by Mr. Ron Sanders, Executive Director of the Wharton Chamber of Commerce to hold the annual City-Wide Garage Sale in Guffey Park, Riverfront Park and the City of Wharton parking lot at the corner of Fulton and Caney Streets on Friday, June 14, 2013 through Saturday, June 15, 2013. Mayor Domingo Montalvo, Jr. stated that Mr. Sanders requested the item be pulled from the agenda.

The twelfth item on the agenda was to review and consider a resolution of the Wharton City Council approving an Interlocal Agreement between the City of Wharton and the Houston-Galveston Area Council for E 9-1-1 Public Safety Answering Point Services and authorizing the Mayor of the City of Wharton to execute the agreement. City Manager Andres Garza, Jr. presented a memo from Police Chief Tim Guin regarding the submission of an Interlocal Agreement for E 9-1-1 Public Safety Answering Point Services between the City and Houston-Galveston Area Council. City Manager Garza stated that this was a biannual agreement that was necessary for the Police Department to operate the Public Safety Answering Point for 911. City Manager Garza further presented the draft Interlocal Agreement for E 9-1-1 Public Safety Answering Point Services and a draft Resolution authorizing the Mayor of the City of Wharton to execute the agreement on behalf of the City. After some discussion, Councilmember Karen Schulz moved to approve City of Wharton Resolution No. 2013-29, which read as follows:

CITY OF WHARTON RESOLUTION NO. 2013–29

A RESOLUTION OF THE WHARTON CITY COUNCIL APPROVING AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF WHARTON AND THE HOUSTON-GALVESTON AREA COUNCIL FOR E 9-1-1 PUBLIC SAFETY ANSWERING POINT SERVICES AND AUTHORIZING THE MAYOR OF THE CITY OF WHARTON TO EXECUTE THE AGREEMENT.

- **WHEREAS,** the City of Wharton is a local government that operates a Public Safety Answering Point (PSAP) Service and;
- **WHEREAS,** the Interlocal Agreement for E 9-1-1 Public Safety Answering Point Services would be effective September 1, 2013 to August 1, 2015 and;
- **WHEREAS,** the Wharton City Council wishes to authorize the Mayor of the City of Wharton to execute an Interlocal Agreement between the City of Wharton and the Houston-Galveston Area Council for E 9-1-1 Public Safety Answering Point Services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS hereby:

Section I. The Wharton City Council hereby authorizes the Mayor of the City of Wharton to execute an Interlocal Agreement between the City of Wharton and the Houston-Galveston Area Council for E 9-1-1 Public Safety Answering Point Services.

Section II. That this resolution shall become effective immediately upon its passage.

Councilmember Al Bryant seconded the motion. All voted in favor.

The thirteenth item on the agenda was to review and consider a resolution of the Wharton City Council amending Resolution 2013-24 awarding a contract for the extension of the sanitary sewer line on Stadium Road to Mercer Construction and authorizing the City Manager of the City of Wharton to execute all documents relating to said contract. City Manager Andres Garza, Jr. presented a draft resolution amending Wharton City Council Resolution 2013-24 regarding the contract between the City of Wharton and Mercer Construction for the extension of the sanitary sewer line on Stadium Road. City Manager Garza further presented Mercer Construction's cost estimate for an eight (8) inch Sanitary Sewer Line in the amount of \$20,945.00 as opposed to the six (6) inch line in the amount of \$19,570.00 that was approved at the City Council meeting held April 22, 2013. City Manager Garza stated that the City Staff had submitted the six (6) inch cost estimate instead of an eight (8) inch cost estimate to the City Council and the cost of the eight (8) inch sewer line was still within the amount paid by the developer. After some discussion, Councilmember Don Mueller moved to approve City of Wharton Resolution No. 2013-30, which read as follows:

The fourteenth item on the agenda was to review and consider the approval of a revision to the City of Wharton Application and Agreement for Utility Services. City Manager Andres Garza, Jr. presented a memo from Finance Director Joan Andel outlining the addition of a Retail Service Agreement that would be added to the City of Wharton Application and Agreement for Utility Service. Finance Director Joan Andel stated that the Public Works Department had indicated that the Texas Commission on Environmental Quality (TCEQ) required this information be present on any utility service application. Mrs. Andel presented the City of Wharton Application and Agreement for Utility Service with the Retail Service Agreement on Page 3. City Manager Garza stated that the City Council Finance Committee had met and

recommended City Council consider approval the revision to the City of Wharton Application and Agreement for Utility Services. After some discussion, Councilmember Al Bryant moved to approve the revision to the City of Wharton Application and Agreement for Utility Services as required by the Texas Commission on Environmental Quality (TCEQ). Councilmember Karen Schulz seconded the motion. All voted in favor.

City Manager Garza presented the Fixed Base Operator Hangar Lease agreement that the City had with Charlie McBride, a draft Fixed Base Operator Hangar Lease agreement with the City and Larry David and a draft Resolution authorizing the Mayor of the City of Wharton to execute the agreement on behalf of the City.
