MINUTES OF CITY OF WHARTON SPECIAL CITY COUNCIL MEETING JULY 15, 2014

Mayor Domingo Montalvo, Jr. declared a Special Meeting duly open for the transaction of business at 6:00 P.M.

The third item on the agenda was Requests for Funding:

A. Crisis Center

City Manager Andres Garza, Jr. presented a letter from Mr. Eugene Davis, Executive Director of The Crisis Center, requesting assistance from the City of Wharton in the amount of \$5,000. Mr. Davis stated the additional assistance from the City of Wharton would assist in covering costs that were not covered by grants or other funding sources and the previous years funding assisted over 350 clients. He thanked the City Council for past support and requested support for the following year.

B. SPOT

City Manager Andres Garza, Jr. presented a request from Wharton S.P.O.T. for assistance with the programs spay and neuter program. Mrs. Christine Stransky with Wharton S.P.O.T. presented to the City Council a request of \$3,000 in funding for the Spay and Neuter Program (S.N.A.P.) which was \$500 more than the previous year. Mrs. Stransky stated that Wharton SPOT would match the funding to provide the mobile SNAP unit to assist residents who qualify with free spay and neutering services for their animals.

C. Wharton Chamber of Commerce

City Manager Andres Garza, Jr. presented a request from the Wharton Chamber of Commerce. Mr. Ron Sanders, Executive Director of the Wharton Chamber of Commerce, requested assistance from the City.
