After some discussion, Councilmember Al Bryant moved to approve the afore mentioned funding requests. Councilmember Terry Freese seconded the motion. All voted in favor.

2. S.P.O.T. Wharton County.

Christine Stransky of Wharton S.P.O.T. made a presentation regarding the services provided by S.P.O.T. to the citizens. She then requested \$3,000 from the City of Wharton for the program. After some discussion, Councilmember Al Bryant moved to approve the funding request from Wharton S.P.O.T. in the amount of \$3,000 for the 2017-2018 Fiscal Year Budget. Councilmember Don Mueller seconded the motion. All voted in favor.
