MINUTES OF CITY OF WHARTON REGULAR CITY COUNCIL MEETING MARCH 26, 2018

Mayor Tim Barker declared a Regular Meeting duly open for the transaction of business at 7:00 P.M at City Hall 120 E. Caney Street Wharton, TX. Councilmember Russell Machann led the opening devotion and Mayor Barker led the pledge of allegiance.

The second item on the agenda was Roll Call and Excused Absences. All councilmembers were present.

The third item on the agenda was Public Comments. No comments were given.

The fourth item on the agenda was the Wharton Moment. City Manager Andres Garza, Jr. congratulated Ms. Tina Herrington, Superintendent of Schools - Wharton Independent School District on her award as Educator of the Year from the Wharton Chamber of Commerce. Councilmember Russell Machann congratulated City Manager Andres Garza, Jr. on his award as Special Service Award from the Wharton Chamber of Commerce.

The fifth item on the agenda was to review and consider the City of Wharton Finance Report for February 2018. Finance Director Joan Andel presented the financial report for the month of February 2018. Mrs. Andel stated that the TexPool balance for February was \$480,321.17 with an average monthly yield of 1.3438%. She said the Prosperity Bank balance for February 2018 was \$5,267,704.63 with an average monthly yield of .25%. After some discussion, Councilmember Al Bryant moved to approve the City of Wharton Financial Report for the month of February 2018. Councilmember Don Mueller seconded the motion. All voted in favor.

The sixth item on the agenda was to review and consider a resolution of the Wharton City Council awarding a contract for the installation of new flooring at the Wharton Police Department and authorizing the City Manager to execute all documents related to said contract.

City Manager Andres Garza, Jr. presented quotes and a memorandum from Chief of Police Terry Lynch with his recommendation. City Manager Andres Garza, Jr. presented a copy of the letter dated March 16, 2018 from Mr. Robert Halepeska, Executive Vice President of the M.G. and Lillie A. Johnson Foundation, Inc. awarding the City of Wharton EMS Department a grant in the amount of \$75,000.00 for the purchase of a chassis remount. City Manager Garza stated that City Council acceptance of the grant was required. City Manager Garza presented a memorandum from EMS Director John Kowalik to City Manager Andres Garza, Jr. dated March 21, 2018 regarding the receipt of a \$75,000.00 grant. EMS Director John Kowalik stated the normal grant amount from M.G. and Lillie A. Johnson Foundation, Inc. was for \$50,000, so they were very generous for 2018. After some discussion, Councilmember Russell Machann moved to approve accepting a grant in the amount of \$75,000.00 for the purchase of a chassis from the M.G. and Lillie A. Johnson Foundation, Inc. Councilmember Terry Freese seconded the motion. All voted in favor.

The thirteenth item on the agenda was to review and consider a resolution of the Wharton City Council authorizing the Mayor of the City of Wharton to submit a Letter of Intent for the City of Wharton's participation in the Texas Department of Transportation Aviation Division Capital Improvement Program by submitting an application for funding to be used to construct a new hangar at the Wharton Regional Airport. City Manager Andres Garza, Jr. stated the Wharton Regional Airport Board met March 6, 2018 and voted to recommend to the City Council to consider participating in the Texas Department of Transportation (TxDOT) Aviation Division Capital Improvement Program (CIP) by submitting an application for funding to construct a new hangar at the airport. Airport David Allen stated participation would require the City of Wharton to submit a Notice of Intent (NOI) to TxDOT Aviation and it was his recommendation that the City Council consider approving the request. After some discussion, Councilmember Al Bryant moved to approve the City of Wharton Resolution No. 2018-23, which read as follows:

The fourteenth item on the agenda was to review and consider is an update of City of Wharton Grant Programs. Community Development Coordinator Gwyn Teves presented

an update on the City of Wharton Grant Programs. After some discussion, no action was taken.

The fifteenth item on the agenda was the update of City of Wharton on-going Projects. City Manager Andres Garza, Jr. presented a copy of his memorandum dated March 22, 2018 providing an update on the City of Wharton current projects as of January 31, 2018.

FLOOD REDUCTION (LEVEE) PROJECT

The U.S. Army Corp of Engineers (USACE) Lower Colorado River Phase I Report - City of Wharton Flood Prevention Project and Recommended report is located at the Wharton County Library and the office of the City of Wharton City Secretary for viewing the report may be viewed on line or at http://www.cityofwharton.com/information-a-notices/lcrb-feasibility-study. The City Council authorized the submission of a loan application to the Texas Water Development Board (TWDB) for the first phase of the levee project. The City Staff re-submitted the project to Texas Water Development Board for the 2017 Program Year under the Clean Water State Revolving Fund for loan forgiveness consideration. Also, there has been some federal legislation passed in Congress that may provide funding for the project. The City Staff is working with the Fort Worth District Office regarding the legislation. The USACE is developing the guidance on the process to move this project forward. The City is expecting an announcement from the USACE in late April early May.

DRAINAGE:

1. Stavena Addition Drainage Project.

The design and construction plans are complete. The challenge on this project is to find locations to place approximately 35,000 cubic yards of soil.

2. Ahldag Ditch Improvement.

The project was approved by the City Council. Public Works Director is currently working out the details.

3. On-going Drainage and Maintenance Program.

The Public Works Department has continued working on cleaning residential draining ditches that have experienced poor drainage.

4. Pecan Acres (Mahann, Kinkaid, Delmas) Drainage Project.

The project area has been surveyed and an improvement plan has been developed by Schibe Engineering. The City Staff has contacted property owners for the necessary easements needed to install the drainage pipes. All four (4) property owners have executed the drainage agreements and have been accepted by the City

Council. The Public Works Department will begin the installation of drainage pipes in the near future.

WATER/SEWER IMPROVEMENTS:

1. **On-going Water and Sewer Maintenance Program.**

Water leaks and sewer failures are still being seen in the month of February.

2. Alabama Street Sewer Line Project.

The project has been completed and grant closeout had begun.

STREET IMPROVEMENTS

1. FM 1301 Extension and Overpass Project Progress Report.

IDC Inc. has submitted to TxDOT Yoakum District Office all required plans for the project. The City Staff continues to coordinate with TxDOT to ensure the project continues to move forward. The City is awaiting TxDOT announcement of the project to be funded in Wharton County.

2. I-69 Project.

The City submitted the comments as approved by the City Council to TxDOT.

3. NanYa Exit Ramp Project.

TxDOT has been coordinating with NanYa on the exit design.

4. 2018 City Street Improvements.

The City 2017 Street Improvement Program was approved by the City Council. The project has been placed on hold due to Hurricane Harvey flooding event.
