MINUTES OF

CITY OF WHARTON REGULAR CITY COUNCIL MEETING SEPTEMBER 10, 2018

Mayor Tim Barker declared a Regular Meeting duly open for the transaction of business at 7:00 P.M at City Hall 120 E. Caney Street Wharton, TX. Councilmember Russell Machann led the opening devotion and Mayor Tim Barker led the pledge of allegiance.

Councilmember's present were: Mayor Tim Barker and Councilmembers Al Bryant,

Terry Freese, Alice Heard-Roberts, Don Mueller,

Russell Machann and Steve Schneider.

Councilmember absent were: None.

Staff members present were: Finance Director Joan Andel, City Secretary Paula

Favors, City Attorney Paul Webb, Public Works Director Wade Wendt, Assistant to City Manager Brandi Jimenez and Airport Manager David Allen.

Visitors present were: Christopher Reina with the Boys and Girls Club of

Wharton, Clifford Grimes, representative with the Boys and Girls Club of Wharton, Albert Villegas with the Wharton Journal Spectator, Sandy Sanders and Wharton Chamber of Commerce Executive Director

Ron Sanders.

The second item on the agenda was Roll Call and Excuses Absences. All members were present.

The third item on the agenda was Public Comments. No comments were given.

The fourth item on the agenda was the Wharton Moment. Assistant to the City Manager Brandi Jimenez stated City Manager Andres Garza, Jr. was home and resting comfortably after a recent procedure. City Attorney Paul Webb stated he was thankful that where the United States of American was presently as to where it was on September 11, 2001.

The fifth item on the agenda was Public Hearing: Proposed Budget for the City of Wharton, Texas Fiscal Year October 1, 2018 to September 30, 2019. Mayor Tim Barker opened the meeting at 7:06 p.m. No comments were made. Mayor Tim Barker closed the meeting at 7:07 p.m.

The sixth item on the agenda was to review and consider action on changes to the Proposed Budget for the City of Wharton, Texas Fiscal Year October 1, 2018 to September 30, 2019. After some discussion, Councilmember Russell Machann moved to approve the Proposed Budget for the City of Wharton, Texas Fiscal Year October 1, 2018 to September 30, 2019. Councilmember Al Bryant seconded the motion. All voted in favor.

The seventh item discussed on the agenda was to review and consider a presentation by Mr. Christopher Reina with the Boys & Girls Club of Wharton on the merger agreement with the Boys & Girls Club of Greater Houston. Mr. Christopher Reina presented the agreement of a merger between the Boys & Girls Club of Wharton and the Boys & Girls Club of Greater Houston. Finance Director Joan Andel stated the City Council had agreed to deed the property that was owned by the City of Wharton that the current Boys & Girls of Wharton facilities were on in order to assist in the merge and had agreed to the arrangement with the condition that the properties would be deeded back to the City if the Boys & Girls Club of Wharton no longer utilized the facilities. Mrs. Andel presented a copy of the draft agreement terms between the Boys & Girls Club of Wharton and the Boys & Girls Club of Greater Houston. She said that the City had been advised that without the following terms the merger would not take place:

* Assurances have been expressed that non-profit organizations would assist if a purchase did have to be made.

Mrs. Andel stated that the draft terms for the merger would release the Boys & Girls Club of Wharton from the City's arrangement and would turn the property over to the Boys & Girls Club of Greater Houston after a term of 5 years. After some discussion, Councilmember Don Muller moved to table the item until further review of the agreement could be made. Councilmember Al Bryant seconded the motion. All voted in favor.

The eighth item discussed on the agenda was to review and consider the reading of the minutes from the regular meeting held August 13, 2018 and August 27, 2018 and special meeting held August 20, 2018. After some discussion, Councilmember Al Bryant moved to approve the reading of the minutes from the regular meeting held August 13, 2018 and August 27, 2018 and special meeting held August 20, 2018. Councilmember Steve Schneider seconded the motion. All voted in favor.

The ninth item discussed on the agenda was to review and consider a request by Mr. Ron Sanders, Executive Director of the Wharton Chamber of Commerce & Agriculture, for City of Wharton assistance by approving the following for the Party under the Bridge to be held Thursday, September 27, 2018:

- A. Closing to traffic from 4 pm to 8 pm a portion Colorado Street from Dinosaur Park to underneath the northbound lane of Business 59.
- B. Closing to traffic from 4 pm to 8 pm the U-shaped access road from the south side of the Dinosaur parking lot to Colorado Street.
- C. Traffic control as needed.

- D. Access to electrical power in close proximity as possible to the entrance to the park at Colorado Street.
- E. Trash cans, and if possible, clean up.
- F. Labor to pick up, set up and return rented tables and chairs from Simply Devine Event Center.
- G. Allow open containers within Dinosaur Park, and Colorado Street within Dinosaur Park as it runs south to underneath the northbound lane of Business 59 from 5 pm to 8 pm.

Finance Director Joan Andel presented a letter dated August 24, 2018 from Wharton Chamber of Commerce Executive Director Ron Sanders regarding the celebration of the re-opening of the Colorado Bridge. Mrs. Andel stated the event would be held on Thursday, September 27, 2018 from 5:00 p.m. to 7:30 p.m. After some discussion, Councilmember Russell Machann moved to approve the afore mentioned request of items A. through G. Councilmember Terry Freese seconded the motion. All voted in favor.

The tenth item on the agenda was to review and consider a resolution of the Wharton City Council authorizing the purchase of a ceilometer for the Wharton Regional Airport and authorizing the Mayor of the City of Wharton to execute all documents related to said purchase. Finance Director Joan Andel presented a resolution authorizing the Wharton Regional Airport to purchase a ceilometer. Airport Manager David Allen stated the current ceilometer at the airport was no longer operational and the City of Wharton had a contract with DBT Transportation Services, LLC that would replace the ceilometer. Mr. Allen said the total costs for the ceilometer was \$28,120.00, which was eligible for fifty (50) percent reimbursement under the Routine Airport Maintenance Program (RAMP). After some discussion, Councilmember Al Bryant moved to approve City of Wharton Resolution No. 2018-70, which read as follows:

CITY OF WHARTON RESOLUTION NO. 2018-70

A RESOLUTION OF THE WHARTON CITY COUNCIL AUTHORIZING THE PURCHASE OF A CEILOMETER FOR THE WHARTON REGIONAL AIRPORT AND AUTHORIZING THE MAYOR OF THE CITY OF WHARTON TO EXECUTE ALL DOCUMENTS RELATED TO SAID PURCHASE.

WHEREAS, The Wharton Regional Airport wishes the City Council to approve the

purchase of a ceilometer; and,

WHEREAS, The City of Wharton currently has a contract with DBT Transportation

Services, LLC for the replacement of the ceilometer; and,

WHEREAS, The Wharton City Council wishes to authorize the City Staff to

purchase the ceilometer for the Wharton Regional Airport in the

amount of \$28,120.00; and,

WHEREAS, The Wharton City Council wishes to authorize the Mayor to execute

any documents related to said purchase.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS:

SECTION I. The Wharton City Council hereby authorizes the purchase of the

ceilometer for the Wharton Regional Airport in the amount of \$28,120.00

SECTION II. The Wharton City Council hereby authorizes the Mayor of the City of

Wharton to execute any documents related to said purchase.

SECTION III. That this resolution shall become effective immediately upon its passage.

The eleventh item on the agenda was to review and consider a resolution of the Wharton City Council approving an agreement between the City of Wharton and the Texas Department of Transportation Aviation Division, for the Routine Airport Maintenance Program, TxDOT CSJ No. M1913WHRT, for the Airport maintenance at the Wharton Regional Airport and authorizing the Mayor of the City of Wharton to execute all documents related to said contract. Finance Director Joan Andel presented a copy of the 2019 Routine Airport Maintenance Program (RAMP) Grant for the Wharton Regional Airport. Airport Manager David Allen stated the City of Wharton had participated in the RAMP Program in the past years and wished to continue participating. After some discussion, Councilmember Al Bryant moved to approve City of Wharton Resolution No. 2018-71, which read as follows:

Community Development Coordinator Gwyn Teves stated the City of Wharton was required to commit matching funds for the FEMA Hazard Mitigation Grant Program and the City was planning to match the funds with the funds allotted in the CDBG-DR Method of Distribution. - **WHEREAS,** The City has applied for FEMA Hazard Mitigation Assistance funds to provide the City with funding for critical facility generators; and
- **WHEREAS,** The City has been allocated funds for Harvey CDBG-DR Infrastructure projects through the regional Method of Distribution process for which the generators are an eligible activity; and

**WHEREAS.** The City anticipates receiving its CDBG-DR allocation in the first quarter of 2019.
