### MINUTES OF CITY OF WHARTON REGULAR CITY COUNCIL MEETING DECEMBER 10, 2018

Mayor Tim Barker declared a Regular Meeting duly open for the transaction of business at 7:00 P.M at City Hall 120 E. Caney Street Wharton, TX. City Manager Andres Garza, Jr. led the opening devotion and Mayor Tim Barker led the pledge of allegiance.

The second item on the agenda was Roll Call and Excuses Absences. After some discussion, Councilmember Al Bryant moved to excuse Councilmember Steve Schneider. Councilmember Terry Freese seconded the motion. All voted in favor.

The third item on the agenda was Public Comments. No comments were given.

The fourth item on the agenda was the Wharton Moment. City Manager Andres Garza, Jr. stated the United States of America lost the perfect example of a dedicated public servant with the passing of President George H. Bush. City Manager Garza congratulated Mrs. Sandy Sanders on her retirement after serving 47 years with Wharton County as the County Clerk. City Manager Garza also congratulated City Secretary Paula Favors on being names the Salt Grass Chapter of the Texas Municipal Clerks Association "Clerk of the Year" for 2018. Councilmember Terry Freese thanked Assistant to the City Manager Brandi Jimenez for her hard work on the holiday decorations at City Hall.

The fifth item on the agenda was to review and consider reading of the minutes from regular meetings held November 13, 2018 and November 26, 2018. City Manager Andres Garza, Jr.

presented a draft copy of the minutes from the regular meetings on November 13, 2018 and November 26, 2018. After some discussion, Councilmember Russell Machann moved to approve the reading of the minutes from the regular meetings held November 13, 2018 and November 26, 2018. Councilmember Don Mueller seconded the motion. All voted in favor.

The sixth item on the agenda was to review and consider a request by City of Wharton for variances for Wharton A. Jackson, Block 60A, Lot 29A. City Manager Andres Garza, Jr. stated the City of Wharton was requesting variances on the properties for residential housing to be built by the Mennonite Disaster Service in conjunction with the Wharton Housing Finance Corporation. Community Development Director Gwyn Teves stated the variances were to go before the Planning Commission on Monday, December 10, 2018 but due to a lack of quorum the City Staff was recommending the City Council consider approving the variances. After some discussion, Councilmember Al Bryant moved to approve the variances for Wharton A. Jackson, Block 60A, Lot 29A. Councilmember Terry Freese seconded the motion. All voted in favor.

The seventh item on the agenda was to review and consider a request by City of Wharton to Re-Plat Wharton A. Jackson, Block 60A, Lot 29A to subdivide for two residential lots. City Manager Andres Garza, Jr. stated the City of Wharton would be re-platting the lot into two lots to subdivide for residential housing to be built by the Mennonite Disaster Service in conjunction with the Wharton Housing Finance Corporation. Community Development Director Gwyn Teves stated the replat was to go before Planning Commission on Monday, December 10, 2018 but due to a lack of quorum the City Staff was recommending the City Council consider approving Re-Plat. After some discussion, Councilmember Russell Machann moved to approve the Re-Plat of Wharton A. Jackson, Block 60A, Lot 29A to subdivide for two residential lots. Councilmember Alice Heard-Roberts seconded the motion. All voted in favor.

The eighth item on the agenda was to review and consider a request by Mr. Ron Sanders, Executive Director, Wharton Chamber of Commerce, for the following for the Snow Day on the Square:

1. Close to traffic the 100-block of North Fulton Street from 3 pm to 9:30 pm on the day of the event.

2. Provide trash cans on the east side of the square during the above hours.

City Manager Andres Garza, Jr. presented a copy of the letter dated November 19, 2018 from Mr. Sanders to him regarding the Snow Day on the Square on December 21, 2018. After some discussion, Councilmember Al Bryant moved to approve the afore mentioned requests from Mr. Ron Sanders, Executive Director, Wharton Chamber of Commerce, for the Snow Day on the Square on December 21, 2018. Councilmember Russell Machann seconded the motion. All voted in favor.

The ninth item discussed on the agenda was to review and consider a request from the Wharton County Recovery Team for assistance from the City of Wharton for site preparations for new builds on the Westside of town as part of the Wharton West End Initiative Program. City Manager Andres Garza, Jr. presented a copy of the request from Ms. Pattie Odom, Director of Administration for the Wharton County Recovery Team, for assistance from the City of Wharton for site preparations for new home builds on the Westside of town as part of the Wharton West End Initiative Program. City Manager Andres Garza, Jr. stated the City of Wharton Beautification Committee met and voted to submit a project to the Keep America Beautiful Community Restoration and Resiliency Fund. City Manager Garza said the Keep America Beautiful Community Restoration and Resiliency Fund benefited Keep America Beautiful Affiliates that serve communities directly affected by natural and environmental disasters and the fund provided immediate and long-term support for initial and ongoing cleanup efforts and helps rebuild vital public spaces: parks, greenways, community gateways, Main Street/downtown areas, open spaces and more. Code Enforcement Officer Jimmy Nickolyn stated the Beautification Committee was requesting the Council approve submission of the grant application to place a butterfly garden at each of the Croom Parks. Mr. Steven Roberts, President of the Beautification Commission stated all City Parks were surveyed and it was determined that both Croom #1 and Croom #2 were the busiest parks so the Committee choose those parks to request the butterfly gardens be placed. After some discussion, Councilmember Russell Machann moved to approve City of Wharton Resolution No. 2018-102, which read as follows:

The thirteenth item discussed on the agenda was to review and consider a resolution authorizing the submission of an application to the Texas Department of Agriculture for a 2019-2020 Texas Community Development Block Grant Program – Community Development Fund grant of up to \$350,000 to construct system improvements and designate the Mayor as the City's authorized signatory. City Manager Andres Garza, Jr. stated the City of Wharton desired to develop a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low-to-moderate income. City Manager Garza said certain conditions existed which represented a threat to the public health and safety and the City Staff believed it was necessary and in the best interest for the City of Wharton to apply for funding under the Texas Community Development Block Grant Program. After some discussion, Councilmember Al Bryant moved to approve City of Wharton Resolution No. 2018-105, which read as follows:

- **Section VI.** That it further be stated that Wharton, TX is committing \$52,500.00 from its Sewer Fund as a cash contribution toward the administration activities of this citywide sewer system improvements project.
- Section VII. That this resolution shall become effective immediately upon its passage.

The fourteenth item discussed on the agenda was to review and consider the approval and adoption of the Citizens Participation Plan as set forth by the Texas Department of Agriculture (TDA) for the Community Development Block Grant Program (CDBG). City Manager Andres Garza, Jr. stated that in accordance with Federal Law, if there was a significant number of the population who are non-English speaking residents and were affected by the TxCDBG project, such citizens should have 'meaningful access' to all aspects of the TxCDBG project. City Manager Garza said that to provide 'meaningful access', Grant Recipients may need to provide interpreter services at public hearings or provide non-English written materials that were routinely provided in English and examples of such vital documents included application, complaint procedures, complaint procedures, answers to complaints, notices, notices of rights and disciplinary action, and any additional documents that contain information that was critical for obtaining federal services and/or benefits, or is required by law. Community Development Director Gwyn Teves presented a copy of the Citizens Participation Plan. After some discussion, Councilmember Russell Machann moved to approve and adopt the Citizens Participation Plan as set forth by the Texas Department of Agriculture (TDA) for the Community Development Block Grant Program (CDBG). Councilmember Al Bryant seconded the motion. All voted in favor.

The fifteenth item discussed on the agenda was to review and consider a resolution of the Wharton City Council approving a contract between the City of Wharton and Wharton County for Emergency Medical Services for ambulance transport and authorizing the Mayor of the City of Wharton to execute all documents relating to said contract. The sixteenth item discussed on the agenda was to review and consider a request for extension on approval of variance for temporary placement of travel trailers for Hurricane Harvey Flood Disaster Victims. City Manager Andres Garza, Jr. presented a memorandum to him from Community Development Director Gwyneth Teves requesting an additional extension on the approval of the variance for temporary placement of travel trailers for Hurricane Harvey Flood Disaster Victims granted September 11, 2018. Mrs. Teves stated the City Council Housing Committee met on November 27, 2018 and was briefed on FEMA Temporary Housing Units in the City of Wharton. She said on November 27, 2018 FEMA announced the extension of the Temporary Housing Program through August 25, 2019 and the City Staff was requesting that the variance for the temporary housing and travel trailers be extended be considered. After some discussion, Councilmember Al Bryant moved to approve the extension on approval of variance for temporary placement of travel trailers for Hurricane Harvey Flood Disaster Victims until August 25, 2019. Councilmember Alice Heard-Roberts seconded the motion. All voted in favor.

The seventeenth item discussed on the agenda was to review and consider City of Wharton Housing Project:

A. **Resolution:** A resolution of the Wharton City Council accepting resale properties held in trust by the taxing entities.

B. **Resolution:** A resolution of the Wharton City Council declaring certain City of Wharton properties as surplus properties and to designate these properties as affordable housing programs for City of Wharton residents.

C. **Resolution:** A resolution of the Wharton City Council approving the transfer of the City of Wharton real properties to the City of Wharton Housing Finance Corporation and authorizing the Mayor of the City of Wharton to execute all documents related to the property transfer.

Community Development Director Gwyn Teves presented copies of draft resolutions accepting resale properties held in trust by the taxing entities, designating the properties as affordable housing programs for the City of Wharton residents and approving the transfer of the City of Wharton real properties to the City of Wharton Housing Finance Corporation.
