

This Parks Master Plan was an effort of the City of Wharton Park Planning Committee with technical assistance and plan preparation by the LCRA Resource, Planning and Development Department, Community Services. LCRA provides this service as part of LCRA's enabling legislation to assist communities with economic development and to ensure the protection and constructive use of the area's natural resources.

INTRODUCTION

The City of Wharton was named after the brothers John and William Wharton, leaders in the struggle for Texas Independence. In 1846, a plantation community settled in the area by some of Stephen F. Austin's original colonists. The City was built along the Colorado River and now lies at the crossroads of U.S. Highway 59 and State Highway 60, about 45 miles from the Gulf of Mexico and 57 miles southwest of Houston. Wharton is now home to nearly 10,000 residents, the Wharton County seat, and Wharton County Junior College.

PLAN DEVELOPMENT PROCESS

In the spring of 2004, the City of Wharton asked Lower Colorado River Authority (LCRA) to assist the City of Wharton with the development of a parks, recreation and open space master plan. That spring, the Wharton Park Planning Committee developed and mailed out a public parks and recreation survey. The results were compiled to complete a full set of data needed to assess current conditions and develop the master plan. The planning process closely followed the outline of this report:

- 1. Gather data, including
 - o Parkland and facilities inventory parks and schools
 - Special events held in Wharton
 - Wharton historical information
 - o Demographics
 - Other parks/recreation providers in the region
 - o Other recreation and tourism plans for Wharton
 - o City maps and orthographic aerial photographs
 - Parks and recreation public survey
- 2. Assess needs study of the compiled public survey results (demand), area resources, existing and potential parks, recreation, and tourism market
- 3. Identify parks, recreation, open space, and tourism issues, goals and objectives
- 4. Create standards for recreation facilities in Wharton
- 5. Develop planning concepts for the City park system, envisioning the next 10 years
- 6. Finalize prioritization of park needs
- 7. Revise and approve master plan
- 8. Produce, print, and present final plan

There was a 12.69 percent increase in Wharton's population from 1990 to 2000 while the states population grew by 22.8 percent. The county's population growth rate was 3.08 percent. The Texas State Data Center population estimate for the City in January 2004 was 9,405.

Based on population projections from the Texas Water Development Board, in 2010, Wharton will have a population of 11,148 in 2010, the growth rate of 9.77 percent. In 2020, the population of Wharton is projected to be 12,131, with the growth rate of 8.81 percent. By the year 2030, Wharton's population is projected to grow by 8.71 percent to reach 13,188.

NEEDS ASSESSMENT

DEMAND-BASED ASSESSMENT – PARKS SURVEY

In summer 2004, the Parks Committee sent out a survey to assess the parks and recreation needs of the community. A total of 170 surveys were returned. A complete report on the survey results is included in the Appendix B. Respondents were asked to reply to several different questions regarding parks and recreation in Wharton.

Table 2 summaries the responses to identify park and recreation elements deemed to be the most needed:

RESOURCE-BASED NEEDS ASSESSMENT

The resource-based needs assessment examines the assets and resources already in the area for open space, parks and recreation facilities, and defines how they could be used. A significant potential recreation resource in Wharton is the Colorado River. The City currently owns one park, River Front Park, and two other properties along the river, the Wharton Fire Department training field and the waste water treatment plant. Caney Creek and Baughman Slough also pass through the City, and together cause more flood damage than the Colorado River. A system of channels has been built to drain the creeks; more are being planned to improve the drainage system capacity. Flood control levees are also being planned for the City. Properties along these drainage features have potential for future trail development.

The City owns a section of abandoned Sante Fe Railroad right-of-way. The right-of-way connects three parks and the Wharton Junior High School.

STANDARDS-BASED NEEDS ASSESSMENT

The standards-based approach to needs assessment uses community specific standards to determine resources needed to meet the requirements of a given population. Prior to developing the concepts for the park system, the planning team established the preliminary Facility Development Standards. These standards represent the projected needs of Wharton for the next 10 years, based on knowledge of existing needs, past experience, population projections, and comparisons to other Texas community trends. The preliminary standards were used to craft the initial plan concepts. Then the concepts were finalized to create a unified long-term plan, and the final standards were then extracted from the master plan concept. Applying the standards to the current inventory demonstrates a deficit in the categories of park amenities, as in the Table 6.

WISD recreation amenities are included in the 'Current Number' of facilities listed above. However, by National Recreation and Park Association City planning standards, school (and college) facilities are counted as one facility for every two provided by the school. This is because school facilities cannot be fully open to the public at all times.



GOALS AND OBJECTIVES

The Parks Planning Committee set the following goals for Wharton Parks Recreation and Open Space development:

- Improve existing parks to meet anticipated future park and recreation needs of Wharton residents.
- Provide facilities easily accessible from any part of the community.
- Develop a system of connected pathways between parks, businesses, schools, and residential areas, to make Wharton a more 'walkable' community.
- Promote sports and special events (such as tournaments, art and crafts festivals, and concerts.
- Update this plan every five years to reflect change.
- Promote business and tourism growth through quality park and open space development. Objectives to meet these goals include:
 - Complete development of the Sante Fe Trail and develop other trail connections throughout Wharton.
 - Develop playground resources which are safe and secure, but challenging.
 - Provide new and renovated rest rooms in all parks.
 - Install safety lighting in all parks.
 - Develop facilities to accommodate special events and sports tournaments.

MASTER PLAN CONCEPTS

The City of Wharton's existing park properties are well distributed throughout the City for basic recreation needs. This promotes future recreation development based on geographic needs and allows residents access to recreation and open space without facing significant barriers. Though basic recreation facilities are well distributed, the two community parks in Wharton are located on the southernmost part of the City. The master plan calls for future development to focus on three major areas:


- Improving existing parks
- Developing three new parks
- Linking the parks with trails or pathways

IMPROVING EXISTING PARKS


A primary aim for improvements will be on safety for users (especially children), basic recreation needs, and security of the facilities. Many of the park improvements in this plan were identified in individual park site plans in 1998. Most of the parks currently have scattered play equipment with no resilient safety surfacing. If the current equipment is to be retained, it should all be consolidated in a single area with safe surface material. The surface material should meet standards established by the American Society for Testing and Materials.

Additions and improvements are shown for each of the parks below.



CROOM PARK 1

- Convert softball field to Little League field
 - Add another Little League field
- Group shelters
- Concession stand
- Chain link fencing
- Replace existing play equipment with new playscape
- Tot lot
- Connect to City-wide park pathways system

GUADALUPE PARK

This property is open to the public by a short-term lease to the and focus will be on maintaining the open space.

HARRIS PARK

- Replace existing play equipment with new playscape
- Chain link fencing

This property is leased to the City from Wharton Independent School District. A request has been made recently to extend the lease.

JEFFERSON PARK

The Wharton Park Planning Committee proposes allowing this property to be put to another use. Possible proceeds for conversion of use could go to investment in other parks and recreation facilities.

NEW PARKLAND

Three new parks and a boat ramp are being planned for Wharton:

DEPOT PARK

The Southern Pacific Railroad Depot is currently undergoing a historic architectural restoration. This park will be developed on the south end of the depot property, and include the following features:

- Pathways
- Benches
- Decorative 'hardscape'
- Connection to the City-wide pathways system
- Landscaping
- Lighting

PROPOSED 30 ACRE PARK -NORTH

A conceptual master plan was developed for this potential park in 1998. The particular property is currently unavailable, but the general site plan concept is the same, for where ever the park might be built.

- Softball complex (4 fields)
- Soccer fields (5)
- Playscape
- Rest room/concession building
- Covered multi-purpose sport court/pavilion
- Connection to the City-wide pathways system
- Parking
- Landscaping
- Utilities

The City should consider the following important factors when selecting a property for this park:

- Balance of 'community' parkland distribution for the north part of Wharton. The south part
 of Wharton already has the only two community parks in the City: Riverfront Park and
 Croom Park 1.
- A riverfront property option would make the park more attractive as a regional attraction.
- Availability and cost of property options.
- A 'community' park can influence residential and commercial development growth in the area of development. A 'regional' park will have even more influence.

BOAT RAMP

The 25 year agreement between the City of Wharton, Wharton County, and Texas Parks and Wildlife Department to maintain the boat ramp on Pecan Valley Drive has expired. The Wharton Parks Planning Committee has voted to recommend to the City Council that the maintenance agreement not be renewed due to the inadequate conditions of the boat ramp and its location. The Parks Planning Committee also voted to recommend that the City should conduct a study of property along the Colorado River within the City limits to determine an appropriate location for a new boat ramp.

CANEY CREEK PARK

The Caney Creek Conservation Foundation signed a lease with the City of Wharton in October 2005, for a 4.7 acre tract of land along Caney Creek. This project is part of an effort by the foundation to preserve, restore, protect, and enhance the natural, cultural, and commercial resources of the Caney Creek watershed. The Caney Creek Conservation Foundation will operate and maintain the property and facility development. Potential amenities could include:

- Pavilion
- Fishing Pier

- Benches
- Bird viewing platforms or blinds
- Kiosk
- Nesting boxes
- Interpretive signs

The immediate objectives of the foundation before any development occurs include: acquire an inventory of species of the area, obtain an environmental assessment, and conduct a feasibility study of the foundation's remaining master plan objectives.

PATHWAY CONNECTIONS

Future recreation development aims to make Wharton a more 'walkable' community. Along with this master plan, the City is also working to complete a master plan for development of sidewalks throughout the City. Objectives to complete this concept in regard to parks and recreation include:

- The Central Wharton Loop using the following connections:
 - o Completion of the Sante Fe Trail (described below) to,
 - Union Pacific right of way to,
 - o Milam Street right of way;
 - o Includes connection to Railroad Depot Museum, downtown, River Front Park, Croom Park 1, Croom Park 2, Mayfair Park and Wharton Junior High School. The connection across Alabama Road at Croom Park 2 would be along, and near the bottom of the expanded drainage ditch under Alabama Road.
- The North Wharton Loop using the following connections:
 - Trail through Mayfield Park to,
 - o North Alabama Road to.
 - o Tiger Avenue/West Ahldag Avenue to,
 - Fulton Street where it connects back to the Sante Fe Trail, and
 - Connection to Walnut Street from West Ahldag Avenue to Pleasure Park.
- The **West Wharton Loop** may actually be a double loop, using the following connections:
 - o Abandoned Sante Fe railroad to,
 - o North Spanish Camp Road to,
 - o Union Pacific r.o.w. to,
 - o Milam Street (west) to,
 - o Harris Park Trail to.
 - o MLK Boulevard, and
 - o Sheppard Street to connect Guadalupe Park.
- Pathway connections within neighborhoods to parks, to schools and to the college.
- Pathway connections from primary business areas to parks.



In 2004, a plan was completed to develop a trail along the abandoned Sante Fe railroad from South Alabama Road to North Fulton Street. The plan includes shade arbors, a decorative fountain, landscaping and connections to the Wharton Junior High School Track, Mayfair Park, and Croom Park 2. Future development of the abandoned railway right-of-way will include a connection from Croom Park 2 to Croom Park 1. Concept plans have already been developed and approved for construction along this right-of-way section between the two parks. The right-of-way will accommodate a new drainage ditch, the trail and a future road connection between State Highway 60 to South Alabama Road.

PRIORITIZATION AND IMPLEMENTATION

The implementation of this plan considers the following factors to determine facility priorities and project phasing:

- rank of recreation elements in response to the parks survey,
- recreation elements of high need which will also benefit the community desires for increased tourism, enhanced City image, and quality business growth in Wharton,
- other recreation needs identified during the planning process,
- the master plan concepts for integrated development.

PRIORITIZATION

The table shows the final park facilities prioritization.

IMPLEMENTATION

This plan proposes the development be done in two major phases.

PHASE I (0-5 YEARS) – DEVELOPMENT

1) Facility improvements to existing parks:

- A. Complete basic facility improvements to Croom Park 1, Croom Park 2, Guadalupe Park, Harris Park, Pleasure Park and Mayfair Park (as detailed above) including:
 - New playscapes or consolidated play equipment in one area with safety surfacing
 - Improved park lighting

- Ball field fencing
- Parking improvements
- Picnicking facilities
- Perimeter fencing
- Landscaping
- Utilities
- B. Croom Park 2 ball field improvements:
 - Convert softball field to Little League field
 - Add another Little League field
 - Add concession stand
- C. Complete Riverfront Park development as shown in Master Plan Concepts
- 2) Create Depot Park as the depot restoration project progresses.
- 3) Develop the pathway connections:
 - A. Central Wharton Loop
 - B. North Wharton Loop
 - C. West Wharton Loop

PHASE II (6-10 YEARS) - DEVELOPMENT

- 1) Sports Complex Development Create the 30-acre parks as shown in Master Plan Concepts.
- 2) Complete final pieces of other park site plans:
 - A. Group shelter in Croom Park 1
 - B. Group shelter in Croom Park 2
 - C. Football field and rest room in Mayfair Park
- 3) Boat Ramp Development
